

2026 Autumn Open Gardens Weekend Giveaway for Ben Huon Weekend Stay Accommodation Package

Terms & Conditions

1. Promoter

2. Promotion Period

The promotion opens at 12:01am on 1st November 2025 and closes at 11:59pm AEST on 20th April 2026 (“Promotion Period”). Entry is only valid for ticket purchases made during the Promotion Period.

3. Eligibility

Entry is open to New South Wales residents aged 18 years or over at time of entry.

Employees of the Promoter, committee members, volunteers, Friends of the Gardens, and their immediate family members of the Promoter, and any person involved in the promotion’s management are not eligible to enter.

4. How to Enter

To enter, a person must purchase **two (2) weekend tickets** (or more) to the Southern Highlands Botanic Gardens 2026 Autumn Open Gardens Weekend event (to be held on 18th April 2026 through to 20th April 2026) via the official ticketing portal of the Promoter during the Promotion Period. Each valid purchase of two or more tickets constitutes an automatic single entry into the draw. Multiple purchases are permitted, but only one entry per transaction will be accepted, regardless of the number of tickets purchased in a single transaction.

Purchasing tickets at the regular retail price is permitted. No additional payment is required beyond the ticket purchase to enter.

Tickets must be purchased during the Promotion Period through the official event ticketing platform.

5. Prize

One (1) winner will receive:

- A two-night accommodation package at Ben Huon Manor located at 18 May St, Robertson, NSW 2577, Australia, for up to six (6) persons aged 18 years or over (valued at approximately AUD 3,360).
