

Southern Highlands Autumn Gardens Weekend & Plant Fair, Park Proxi Accommodation Giveaway Terms and Conditions

- 1. Promotion Name:** Southern Highlands Autumn Gardens Weekend & Plant Fair, Park Proxi Accommodation Giveaway.

- 3. Competition Period:** The promotion opens at radio advertising airtime and closes at 11:59pm AEST on 6 April 2026 (“Promotion Period”) - DRAW DATE: 10am, 7 APRIL 2026.
- 4. Eligibility:**
 - The competition is open to individuals who are **18 years or older** and are residents of **New South Wales, Australia**.
 - Employees, contractors, and their immediate families of the Promoter are not eligible to enter.
 - Only one entry per person is allowed.
- 5. How to Enter:**
 - To enter, participants must purchase a (one) **weekend pass** for the Southern Highlands Autumn Gardens Weekend and Plant Fair (April 18th and 19th, 2026) through **shbg.com.au**.
 - Participants must include “2GB” in the GIFT CERTIFICATE / PROMOTION CODE section during ticket purchase checkout to be eligible for the draw.
 - Multiple purchases are permitted, but only one entry per transaction will be accepted, regardless of the number of tickets purchased in a single transaction.
 - Purchasing tickets at the regular retail price is permitted. No additional payment is required beyond the ticket purchase to enter.
 - Tickets must be purchased during the Promotion Period through the official event ticketing platform methods.
- 6. Prize:**
 - The winner will receive **two (2) nights’ accommodation** at **Park Proxi Bowral, NSW**, for the **weekend of the Southern Highlands Autumn Gardens Weekend & Plant Fair (the nights of April 17th and 18th - or April 18th and 19th, 2026)**.
 - The prize is **non-transferable, non-refundable, and cannot be exchanged for cash** or any other prize.
 - Any additional expenses, including meals, transport, and personal incidentals, are the responsibility of the winner.
- 7. Winner Selection:**

- The winner will be selected **randomly** from all eligible valid entries received.
- The draw will take place at **10am on Tuesday 7th April, 2026** at the Southern Highlands Botanic Gardens' office.
- The winner will be notified by phone or email within **1 business day** of the draw.
- The winner's name will be published on the Promoter's website and/or social media channels.
- The draw is by chance, and each valid entry has an equal chance of winning.
- The Promoter's decision is final, and no correspondence will be entered into.
- If a substantial change to the promotion is required (e.g., prize value, draw date), the Promoter will notify entrants via the Promoter's website and may declare the changed terms.

8. Prize Claim:

- Accommodation booking must be booked directly with the accommodation provider Park Proxi (or their relevant business name during the competition and prize redemption period).
- The winner must claim their prize within **2 days** of being notified.
- If the winner does not claim their prize within this period, a **re-draw** will occur, and the new winner will be notified within **1 business days of the re-draw**.

9. Privacy:

- By entering, entrants consent to the collection, use, and disclosure of their personal information by the Promoter. The Promoter will handle entrants' personal information in accordance with its privacy policy.
- By entering, participants agree to these Terms and Conditions and consent to their name being published should they be drawn as the winner.
- The winner agrees to participate in reasonable publicity as requested by the Promoter.
- The Promoter will not share personal information with third parties unless required to do so by law.

10. General Terms:

- The Promoter reserves the right to amend or cancel the competition at any time without notice, including changing the prize or competition dates.
- The Promoter accepts no responsibility for any loss, damage, or injury to persons or property that may occur as a result of entering the competition or accepting the prize.
- By entering, participants agree to these Terms and Conditions and consent to their name being published should they be drawn as the winner.

- To the fullest extent permitted by law, the Promoter and its agents exclude all liability (including negligence) for any loss, damage or injury of any kind that is suffered or sustained in connection with this promotion or in redeeming the prize, except where liability cannot be excluded by law.

 2. Technical failures affecting entry process.

12. Conduct:

14. Force Majeure:

- If circumstances beyond control occur (e.g. COVID restrictions, natural disaster, venue closure), Promoter and Park Proxi may:
 - Postpone the experience;
 - Modify itinerary while maintaining equivalent value.

15. Trade Promotion Compliance:
